1. Board fee for mare is \$6.00 per day, wet or dry. Mare will not be released and no Breeder's Certificate will be issued until all expenses and board have been paid in full.
2. Requirements for mares coming onsite to Foothills Ranch. The mare shall be in a healthy and sound breeding condition, free from infectious, contagious, and transmissible disease. A current Coggins test, veterinarian issued health certificate, must accompany mare. Foothills Ranch reserves the right to refuse mare if not in satisfactory condition. Mares that are not halter broke will not be accepted.
3. Foothills Ranch Live Foal Guarantee is based upon adherence to the following conditions.
 - All Stallion Service Fees, board and all applicable expenses must be paid in full.
 - The Mare must be pregnancy checked and found to be in foal between 90 to 210 days by a certified Veterinarian. If the mare is found to be open, a Veterinarian Certificate must be mailed to the stallion owner within 30 days.
 - In the event that the mare fails to produce a live foal, the stallion owner MUST be notified by certified mail or by telephone within 48 hours of the foal's death. In addition, the Breeder's certificate must be returned to the stallion owner within 60 days of the foal's death.
 - Foothills Ranch agrees to offer an additional return breeding, in the succeeding year, for any Mare that fails to produce a live foal.

It is further agreed that should the stallion die or become unfit for service, or if any mare should die or become unfit to breed, then this contract shall become null and void, and any money paid less expenses incurred shall be refunded to the mare owner.

The mare owner agrees that Foothills Ranch will not be responsible for any disease, accident, sickness or death to the mare or foal, and that the stallion manager will exercise his or her own judgment in supervising and caring for the mare. The mare shall be healthy and in sound breeding condition. Foothills Ranch reserves the right to refund stallion services to any mare proven unfit for breeding. The mare owner will likewise not be responsible for any disease, accident, sickness or death to the stallion.

A Photostat copy of the Mare Registration Certificate (if registered), must be returned with this contract.

When Stallion Owner and Mare Owner sign the Contract, it will be binding on both parties, subject to the above terms and conditions
