



FOOTHILLS RANCH STALLION BREEDING CONTRACT

This agreement is effective as of this _____ day of _____, 20____ executed in the town of Roseisle Manitoba

I hereby agree to breed the mare _____

Reg.# _____ to the stallion **SMOKIN AMMO** for the 20____ season. The stallion fee is \$1000.00 which includes a booking fee of \$250.00 First chute / collection fee included in stallion fee. Additional collection / chute fee stated below in fee schedule if required. The stallion fee stated above includes a \$250.00 non-refundable booking fee which shall be payable upon execution of this contract. Balance to be paid prior to breeding mare with cooled semen or prior to shipping cooled or frozen.

A. FOR COOLED OR FROZEN SHIPPED SEMEN: Shipping fees will be determined by Elm Creek Equine Vet Services depending on location of shipment. <https://elmcreekequine.com>

B. LIVE FOAL GUARANTEE. If the mare fails to produce a live foal from the privilege granted by this agreement, the mare Owner may re-breed the Mare (or a substitute mare mutually agreed upon by the Mare Owner and Breeding manager) during the subsequent breeding season. The Mare Owner may not assign this breeding contract or substitute any other mare for the Mare under this agreement without the prior written consent of the Breeding Manager. "LIVE FOAL" means that the foal resulting from the breeding stands and nurses without assistance and lives for 24 hours. The return one time re-breeding privilege is conditioned upon the Mare Owner giving the Breeding Manager written notice within 3 days after foaling or aborting that the Mare did not produce a live foal. There will be a \$250.00 charge for "re-breed" services plus shipping fees as listed below.

C. "Breeders Certificate" shall be issued for the foal conceived when stallion fees and all other expenses have been paid in full. The mare owner shall receive a Breeders Certificate when the Breeding manager has been notified that a live foal has been produced.

D. ENTIRE AGREEMENT/GOVERNING LAW/VENUE. This Agreement contains the entire agreement between the parties and may be amended only in writing signed by each of the parties. Manitoba law governs this Agreement, all of the terms and provisions of which are performable in Manitoba. The parties agree that any legal action brought under this agreement or pertaining to the subject matter of this Agreement can only be brought in Manitoba, subject to any Manitoba law or statute.

E. THIS AGREEMENT shall be binding upon the parties hereto, upon execution hereof, and the same may not be altered or amended, except by written mutual consent of the parties hereto. Contract expires 2 years after execution.

F. Please submit signed contract, booking fee and a copy of registration certificate front and back.
